In accordance with 46 CFR Subpart D, evidence which establishes chain of title from the last documented owner (William Brown) up to the present owner (Crosswinds Ocean Charter LLC) is required. An instrument such as a bill of sale may be submitted. There is an \$8.00 per page filing fee for each bill of sale that is submitted. The vessel is subject to an outstanding mortgage US Bank NA. In accordance with 46 CFR Part 67.145, the mortgagee must either release the mortgage – OR – execute an Application, Consent and Approval for Exchange of Certificate of Documentation (CG-4593), acknowledging the requested change(s) and consenting to the same. There is no fee to release a mortgage; however, there is a fee of \$24.00 for the Application, Consent and Approval for Exchange of Certificate of Documentation (CG-4593). The submitted CG-1258 is incomplete and needs clarification:

- 1. Section J. Endorsements for which application is made, was not addressed.
- 2. Section K, Primary Service, you indicated a service for a commercial vessel. Please clarify.
- 3. If the LLC is member managed (organized like a general partnership), the form must be signed by or on behalf of a member and indicate their capacity as such. A list of all members is required.
- 4. Section M, items 1-4, please address.

Therefore, please submit a new, fully completed and properly signed CG-1258. There is no fee for this submission.

Based on your future submission, additional information may be required.

Paperwork will be retained for 90 days from the date of this letter. If no response is received within that time frame, filings will be terminated, and paperwork returned.
